## GOLF CART RENTAL AGREEMENT

### Terms:

1. Lessee acknowledges receipt of the equipment identified above (the "Equipment") which was examined by Lessee and found to be in first-class condition upon receipt, except as noted below. Lessee further acknowledges that the equipment is leased by Mountain Lake Campground ("Lessor") to Lessee for the use and purpose for which it was manufactured subject, however to the terms and conditions set forth herein.

2. Lessee shall return the equipment to the place of initial rental no later than the date and time

specified above (LESSEE SHALL CONTACT LESSOR BEFORE SAID TIME IF AN EXTENSION IS DESIRED) or upon Lessor's demand therefore. The equipment shall be returned in the same condition as when received, ordinary wear excepted.

3. Lessee shall pay to Lessor upon demand rental for the equipment at the rate specified above for the period specified above. In the event the equipment is not returned on a timely basis, daily rates will apply unless other arrangements are made with Lessor in advance. Daily rates will apply if the equipment is kept after the scheduled return date. All days, including weekends and holidays are chargeable.

4. Lessee is responsible for all damages to the car during the rental period and shall reimburse Lessor upon demand for the loss of, or any damage to the equipment or property damage while it is rented to Lessee and for all costs and expenses, including reasonable attorney's fees incurred by Lessor in collecting any amounts owing be lessee hereunder or in otherwise enforcing Lessor's rights hereunder. Any security deposit can be utilized by Lessor for assessed damages.

*Sample schedule of charges for damages:*

Headlight . . . . .	\$ 65
Windshield . . . . .	\$155
Leaning left or right . . . . .	\$150
Bench seat cut or burn. . . . .	\$150
Steering repairs . . . . .	\$250
Seat back cut or burn . . . . .	\$150
Front body repairs . . . . .	\$220
Mid/Rear body repairs. . . . .	\$300

5. Lessee shall indemnify and hold Lessor harmless from and against any and all liability, including bodily injury and property damage arising out of the use or operation of the equipment by Lessee or anyone using or operating same with Lessee's express or implied consent; provided, however, that Lessor shall be responsible for loss or damage resulting from lessor's sole negligence.

6. Lessee shall abide by all rules and regulations of Lessor governing the use of the equipment.

7. Lessee shall not assign this Rental Contract or sublease the equipment.

8. Lessee will allow Lessor to make a photocopy of the driver's license of the person(s) renting and other authorized driver(s) of the equipment.

**Golf Cart Rules:**

1. Lessee/operator(s) of the golf cart must be 21 years of age and have in their possession a valid unrestricted driver's license. Cart privileges are forfeited if underage driver caught on cart!
2. Pedestrians ALWAYS have the right of way.
3. Lessee is responsible for all actions of all passengers and persons operating the cart with his/her express or implied permission.
4. Under no circumstances may the operator be under the influence of any intoxicating substance (i.e. drugs, alcohol, etc.). Doing so will result in revocation of the person's renting and operating privileges for the rest of their visit.

5. Golf carts cannot be operated from dusk to 8:00am
6. Golf carts must be operated properly. Horseplay, racing or other misuse of car will not be tolerated.
7. Pedestrians always have the right of way.
8. Carts are to be operated on Campground roads only. Golf carts are not allowed outside the Campground or on public highways, campsites, fields, marina, or anywhere else on Airport Road.
9. No driving thru campsites or other restricted areas.
10. Golf carts must be returned at the designated time set forth above. Late returned carts will be charged \$5 per hour for each hour or portion thereof the cart is late returning.
11. Golf carts can carry a maximum of 4 people and all passengers must be seated at all times when the car is in motion.
12. Please report any malfunctions to management immediately.
13. Anyone found abusing the rules and regulations of a rental golf cart will immediately forfeit all rental privileges. There will be no refunds made if the cart has to be returned because of lessee misuse as determined by Lessor personnel. Loss of security deposit will also result if cart is misused or damaged. There are no second chances!
14. Violating any of the following rules will be cause for immediate loss of rental privileges, payment and deposits:
  - a. Underage drivers – anyone under 21 operating the golf cart.
  - b. Invalid or no driver’s license presented upon request.
  - c. Reckless driving
  - d. Operating the cart outside the Campground.
